Prohibitions, duties, restrictions ad other conditions

- The crew of a vessel should periodically review the vessel and, if necessary, correct the ropes and fenders to ensure safe standing at port in changed weather conditions, changed water level, etc.
- The crew is forbidden to pollute the water area and territory of the harbour.
- Emptying toilets and septitanks in the harbour is prohibited, the polluter must pay all costs of cleaning.
- All orders of the harbour master regarding vessels staying at the harbour, entering the harbour, and departure from the harbour are mandatory for both skipper and all members of the crew, as well as the person responsible for the vessel.
